CIRCULAR

The Management is hereby informed all the Heads of the Institution that, the holidays applicable to the employees of SJR Education Society and its Institutions from the Calendar Year 01.01.2022.

1. **Casual Leave** : An employee shall be entitled to 12 days of casual leave during the calendar year.
The maximum availment of casual leave at a time will be 5 days.
Every employee shall allow 2 half day leave in a month.
Public holidays declared by the establishment and weekly holidays can be prefixed or suffixed to casual leave subject to the condition that the total period shall not be exceed seven days at a time.
2. **Restricted Holiday**: 1 day from the calendar Year 2022.
3. **Earned Leave**:
All permanent employees shall be entitled to earned leave for every year of service as given below:
 - a. Non-Vacation Employee: 20 days for Principal and Non-Teaching Staffs.
 - b. Vacation Employee: 10 days for Teaching Staffs
 - c. Leave will be credited in two installments on first day January and July of the calendar year.
 - d. During the service period unused earned leave can be encashed (Basic + DA)for a maximum of 30 days in 2 years.
 - e. Public holidays declared by the establishment and weekly holidays can be prefixed or suffixed to Earned leave subject to the condition that the total period shall not be exceed Ten days at a time.
 - f. The minimum earned leave availment will be 1 day, earlier sanctioned by the Management.
